2. 3. The management has remitted an amount of Rs.11,166/- vide challan No.2021-CA-062102, Dt.07-01-2022 towards fire precautionary fees for name change.

4. Therefore, **Name Change in Fire No Objection Certificate** issued to M/s.Vijayam School D.No.9-137/3, Kommadi Village Road, Madhurawada, Visakhapatnam **is up to 10-12-2024** and the **Management shall submit the application for Renewal of Fire No Objection Certificate two (2) months before the date of expiry.**

5. The issuing of Fire NOC will be without any Prejudice to take action by GVMC against the unauthorized constructions if any made.
