Previously Temporary Recognition has been granted to the classes I to V under EM for the years from 2011-12 to 2015-16 to Vijayam School, D.No.9-137/3,Kummadi, 100 Ft Road Madurawada, Visakhapatnam District in the reference 1<sup>st</sup> cited. The Correspondent, Vijayam School, Midilapuri Colony, Madurawada, Visakhapatnam District (under the Management of Dr. Kantipudi Vijaya Lakshmi Educational Society, Indra nagar, Visakhapatnam District Regd.No.130/2011) has submitted the application for Extension of Temporary recognition for classes I to V under English Medium for the years in the school from 2016-17 to 2025-26 in the reference 2<sup>nd</sup> cited.

The Mandal Educational Officer, Anandapuram has verified the application for Extension of temporary recognition with reference to the conditions laid down in the previous orders and G O Ms.No.1 Edn, dated 01.01.1994 and submitted a report in his letter 4<sup>th</sup> cited. The District Educational Officer, Visakhapatnam here by grants Temporary recognition for a period of 10 years i.e., the academic year from 2016-17 to 2025-2026 to the classes I to V (English Medium) in respect of Vijayam School, D.No.9-137/3,Kummadi, 100 Ft Road Madurawada, Visakhapatnam District subject of the following conditions.

1. That the Educational Institution shall serve the needs of the locality more particularly.
2. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timings vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year.
6. That the records/ accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer, every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer, every year.
9. That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with
10. That the school shall not be closed without giving notice both to the parents/ District Educational Officer, and competent authority at least six months before.
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No objection certificate.
14. The management informed that no thatched roof accommodation is allowed to run the school.
15. Proper and adequate sanitation facility shall be provided for students especially for girl students.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file and affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the School for the academic year.
22. That the management shall take every responsibility for the timely safely and comfortable mobility of the School Children from the residences to School and vice versa.
23. That the School Van should be ensured road worthy for the transportation/ mobility of School Children.
24. That the School Bus should be free from all taxes due and should be maintained with regular checks by authorized mechanism of periodically/ as and when required without causing any sort of dislocation for the School Children opting the bus facility.
25. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the School Van.
26. That the management shall ensure the vehicle and safety girls be provided to the windows of the Vehicle.
27. That the management shall ensure the Accounts of the School audited by an authorized Chartered Accountant every year and submit.
28. The management is hereby informed that the recognition is being given purely on temporary basis and is subject to the report of state level inspection and vigilance committee regarding fulfillment of all the pre-requisite conditions under A.P. Education Act 1982 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
29. The management should display fee structure and pay structure and qualified teachers list on the notice board
30. The management is hereby instructed to submit an affidavit by the end of April in every academic year to the effect that there is no deviation or violation of norms/rules prescribed by the Govt. from time to time. Otherwise, the recognition now granted will be withdrawn without any further notice.

If the management fails to comply with the above conditions promptly the Recognition now granted will be withdrawn without any further notice.



The RJDSE, Kakinada has accorded Additional Sections vide Pr.Rc.No.4490/B1/2013, Dated: 12.11.2013 to the Classes VI-X (VI-02, VII-03, VIII-03, IX-02 & X-02). The Correspondent has submitted the application for Renewal of Recognition for the classes VI to X (English Medium) for a period of 10 years from 2016-17 to 2025-26 in the reference 5<sup>th</sup> cited. The District Educational Officer, Visakhapatnam has verified the application for Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada who is the competent authority for Secondary Schools hereby accords Renewal of Recognition for the classes VI to X (English Medium) for a period of 10 years from 2016-17 to 2025-26, subject to fulfillment of the following conditions in Vijayam School, D.No. 9-137/3, Kommadi 100 Ft Road Madhurawada, Visakhapatnam without Grant in aid now or in future.

That the society shall abide by the instructions/rules and regulations made by the Govt. or authorized officer from time to time

1. That the Educational Institutions shall serve the needs of the locality more particularly.
2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Ednl. Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
10. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least six months before
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit before 30<sup>th</sup> of April every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
22. That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
23. That the management has to maintain trained teachers at all time.
24. To follow the guidelines issued in G.O.Ms.No.91 Edn, Dt.06.08.09 regarding Fee Structure in Private Schools.
25. That the Management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer
26. To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of /Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
27. The preventive measures regarding maintenance of school vehicles/maintenance of vehicles to ensure safety of children as instructed in Pr..Rc.No.276/PS-1/2014-2, Dated.19.06.2015 of the C.S.E., AP, Hyderabad should be followed.
28. Take requisite steps to enlighten all the teachers in the School about the Prohibition of Corporal Punishment in Schools
29. Have adequate personnel to guide the movement of the children to ensure road safety and transportation.
30. The Recognition now accorded is subject to confirmation of genuineness of the NOC issued by the Commissioner, GVMC, Visakhapatnam.
